## PET AGREEMENT

I AUTHORIZE THE HOUND DOG PET HOTEL TO CONTACT MY VET WHEN WARRANTED OR SEEK WHATEVER MEDICAL ATTENTION THEY DEEMED APPROPRIATE AND THAT I AM RESPONSIBLE FOR ANY VETERINARY AND / OR MEDICAL CHARGES.

THE HOUND DOG WILL PROVIDE DUE AND REASONABLE CARE WITHOUT LIABILITY FOR LOSS OR DAMAGE DUE TO DISEASE, DEATH, THEFT, FIRE, ESCAPE, INJURY TO PERSONS, OTHER DOGS AND / OR PROPERTY OR ANY UNAVOIDABLE CAUSE.

THE OWNER AGREES TO PAY THE DAILY BOARDING RATE PLUS ANY ANCILLARY SERVICES OR PRODUCTS REQUESTED, SUCH AS TRANSPORTATION, GROOMING, SPECIAL CARE AND / OR ANY OTHER EXPENSES THAT MAY OCCUR IN THE CARE OF MY PET(S).

I UNDERSTAND THAT ON THE DAY OF ARRIVAL I WILL BE CHARGED A FULL DAY. ON THE DAY OF DEPARTURE I CAN CHECK OUT BEFORE NOON WITH NO ADDITIONAL CHARGES. AFTER 12PM I WILL BE CHARGED FOR THAT CALENDAR DAY.

I AGREE TO PROVIDE CURRENT VETERINARY RECORDS FOR: RABIES, BORDETELLA, DISTEMPER AND NEGATIVE FECAL PARASITE TEST.

I AGREE THAT I AM SOLELY RESPONSIBLE FOR ANY DAMAGES THAT MY PET(S) MAY CAUSE THROUGH MALICIOUS OR IMPROPER CONDUCT. SHOULD EXPENSES NOT BE PAID AND / OR I ABANDON MY PET(S) SEVEN DAYS FROM THE END OF RESERVATION DATE WITHOUT PROPER NOTICE I FORFIET OWNERSHIP OF MY PET(S) AND THEY WILL BECOME PROPERTY OF HOUND DOG PET HOTEL.

I AUTHORIZE THE HOUND DOG PET HOTEL TO CHARGE MY VISA OR MASTERCARD FOR ANY SERVICES RENDERED WHILE TAKING CARE OF MY PET OR ANY LATE CANCELLATION FEES THAT MAY OCCUR.
